Cabinet Regulation No. 618

Pricelist of chargeable services of the Central Statistical Bureau

Issued pursuant to Section 9, Paragraph 5 of the Law on Budget and Financial
Management

1. Cabinet Regulation establishes pricing of chargeable services of the Central Statistical Bureau.
2. Prices of chargeable services of the Central Statistical Bureau are fixed according to the Pricelist of chargeable services of the Central Statistical Bureau (Annex 1 and Annex 1¹).
3. Price of new or Ad hoc chargeable service is calculated taking into account the time spent on the request fulfilment, according to the formula:

$C = L \times S$, where
------------------	---------

C – price of the service delivered; L – time used to fulfil request;
S – rate per 1 hour (in accordance with the Annex 1 and Annex 1¹ to the Cabinet Regulation).

4. Price of the printed publications and Questionnaires prepared by the Central Statistical Bureau (hereinafter – product) is fixed by compiling a breakdown of costs (Annex 2).
5. Price of the printed and other kinds of products (e.g. CD-ROMs) of the Central Statistical Bureau are calculated according to the formula:

$C = \frac{A + P + D}{n}$, where
---------------------------	---------

C – price;
A – authors' fees; P – printing costs;
D – material costs and other costs related to storage, dissemination and sales of the printed materials;
n – number of copies.

6. Payment for the chargeable services provided by the Central Statistical Bureau shall be made using one of the following methods of payment:

- 6.1. through a payment service provider entitled to provide payment services within the meaning of the Law on Payment Services and Electronic Money;
- 6.2. in cash in the Central Statistical Bureau teller's office;
- 6.3. with a payment card at the payment card acceptance terminal of the Central Statistical Bureau or in another alternative system, if the Central Statistical Bureau or the intermediary body technically ensures it.

7. Annex 1 to these Regulations shall apply until 31 December 2013.

8. Annex 1¹ to these Regulations shall apply since 1 January 2014.

9. Annex 1 of these Regulations shall apply to cash payments made in lats during the period of simultaneous circulation specified by the Law on the Procedures for the Introduction of the Euro.
